

Notification Page Parameters

The Trust Online Notifications page has been enhanced to include **Start** and **End** date parameters. Additional Notification Types have also been added to the drop down menu. With these new changes, users will be able to target specific dates and activity notification types in their search results.

Notification Type

The following activity notifications have been added to the Notification Type drop-down menu found in the Attorney Notifications section:

The previous version of this drop-down menu would allow users to select the more general **Activity Notifications (Duplicate Claims, Prepetition, etc.)**, which would produce results that included all of the activity notifications.
